Report:

Background:

Staff received the attached letter from the Kinette Club of Walkerton requesting a donation to assist with the cost of organizing the 2025 Fairytale Feast event in Cargill.

The event has taken place at the Cargill Community Centre in 2023, 2019, 2018 and 2017. The Municipality donated \$300 to the Kinette Club in 2023 to support the Fairytale Feast.

Analysis:

The 2025 Fairytale Feast event will occur on October 25, 2025 at the Cargill Community Centre and invites families to enjoy a locally prepared meal, interact with fellow children and characters in costume, and be treated like royalty for the afternoon.

The event has brought in approximately 1,600 attendees over the past four years of running the event (2023, 2019-2017) and benefits both residents of Brockton and neighbouring communities.

According to the Municipality of Brockton's Donation Policy F19-1999-05, a review of the request has been completed and the total request from the Kinette Club of Walkerton is within the allotted donation entitlement.
