#### 7.1 Access Now Map Mission Day

The Committee reviewed the AccessNow website and app which displays photographs and rates businesses on a level of accessibility. A history of the app was provided, and the Committee confirmed their priorities.

The Committee discussed obtaining a price for aluminum steps and ramps which can be locked onto front doors.

The Committee considered hosting an event prior to major community events to encourage visibility and awareness. The Committee tentatively booked a Map Mission Day for June 13, 2025.
