The Committee suggested creating an incentive for push button doors. The Committee noted upcoming developments at Old Durham Road including the addition of sidewalks, and the projects involved in the Housing Accelerator Fund.

### 8.1 Centennial Park Pavilion Relocation

The Committee discussed extending the concrete to ensure access from both directions, and whether to consider stone or boulders to maintain a natural look. The Committee discussed whether fencing should be considered due to the proximity from the baseball diamond. It was noted that exterior outlets should be higher than the flood plain.
