#### Report:

#### **Background:**

A representative on behalf of Victoria Jubilee Hall attended the March 12, 2019 Council Meeting and requested an increase in funding for Victoria Jubilee Hall in the amount of \$10,000.00 from \$5,000.00. The Municipality of Brockton has provided a donation of \$5,000.00 to Victoria Jubilee Hall for a minimum of ten years. The Municipality of Brockton has also provided snow removal of the Victoria Jubilee Hall parking lot of approximately \$1,500.00 to \$2,000.00 depending on weather conditions.

On March 12, 2019 Council approved the increased funding and requested the Chief Financial Officer prepare a report for the March 26, 2019 meeting, indicating the funding options.

#### **Analysis**:

Since the 2019 Municipal budget was completed on March 7, 2019, staff recommend that additional funding for the Victoria Jubilee Hall come from the Council Reserve Fund. The 2020 Budget will include the increased funded request as part of the operating budget.
