### **Recommendation:**

That the Council of the Municipality of Brockton hereby receives Report Number PW2019-20-Geeson Ave Streetlight Request, prepared by John Strader, Roads Supervisor and further directs staff to install \_\_\_\_\_\_ fixtures in relation to the Geeson Avenue Streetlight Request.

### **Report:**

#### Background:

A request to Council and Staff has been received from a resident to provide illumination on Geeson Ave at the intersection of Highway 9 or at the intersection of Geeson Ave and the Carrick-Brant Townline. A delegation has been brought forward to the April 23, 2019 meeting for more information.

#### Analysis:

The suggested location of installation fell under MTO territory and when reviewing requests to install illumination, the ministry considers a wide range of factors such as geometry, operations, development, and night time collision experience. The Ministry has completed a review of the intersection, and based on established guidelines, conditions for MTO funded street lighting were not met at the time of this request. If the municipality decided to install, maintain and operate illumination, an agreement would have to be made with the ministry. Presently there are no poles to affix illumination at the intersections of Highway 9 or the Carrick-Brant Townline.

Staff have decided to review an alternate location for illumination on the northern side of the intersection. At the present time there are no light fixtures on the Kincardine Highway between Ridout Street and Wallace Street, however there are multiple hydro poles owned by Westario Power Inc. Staff have contacted Westario Power to obtain permission to install fixtures on the poles at the municipalities cost.

A map has been attached of the alternate locations available to provide illumination on the Kincardine Highway between Ridout Street and Wallace Street.
