By-Law 2026-035

Being a By-Law to Declare PT LT 34 CON 1 NDR BRANT, PTS 9 & 10 3R-10640; S/T EASEMENT OVER PT 9 3R-10640; MUNICIPALITY OF BROCKTON, being PIN 33196 - 0616 (LT) and PT LT 34 CON 1 NDR BRANT, PART 1 3R-10027, MUNICIPALITY OF BROCKTON; being PIN 33196-0558 (LT) to be Surplus to the Needs of the Municipality of Brockton.

Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its council;

And Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9; shall be exercised by By-Law;

And Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 270(1), as amended, provides that a municipality may adopt and maintain policies regarding the sale and other disposition of surplus land;

And Whereas By-Law 2026-025– Disposition of Real Property establishes procedures regarding the disposition of real property for The Corporation of the Municipality of Brockton;

Now Therefore the Council of the Corporation of the Municipality of Brockton **Enacts as Follows:**

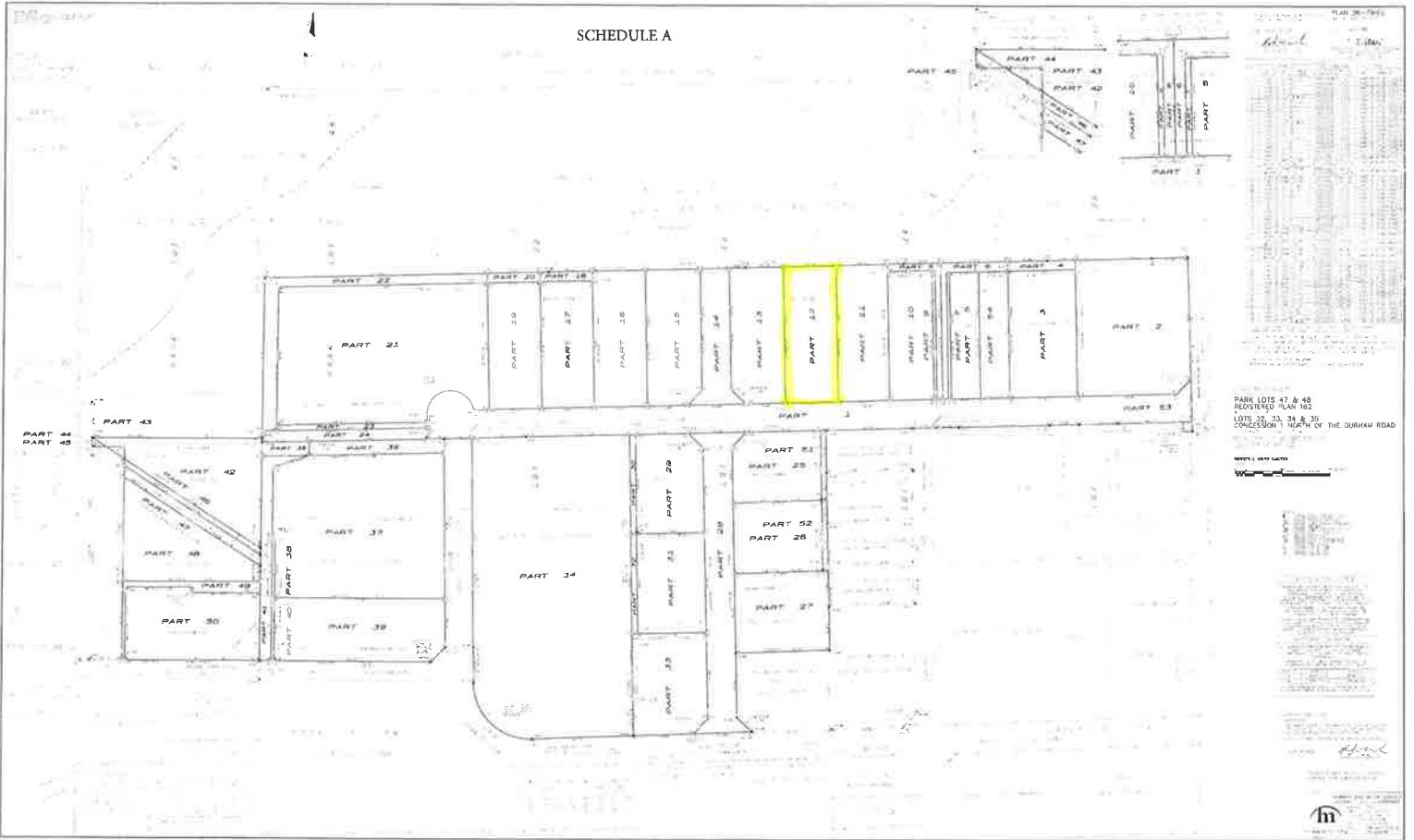
- 1.0 That the property legally described as PT LT 34 CON 1 NDR BRANT, PTS 9 & 10 3R-10640; S/T EASEMENT OVER PT 9 3R-10640; MUNICIPALITY OF BROCKTON, being PIN 33196 - 0616 (LT), as identified on Schedule "A" to this By-Law, is hereby declared surplus to the needs of the Corporation of the Municipality of Brockton;
- 2.0 That the property legally described as PT LT 34 CON 1 NDR BRANT, PART 1 3R-10027, MUNICIPALITY OF BROCKTON; being PIN 33196-0558 (LT), as identified on Schedule "B" to this By-Law, is hereby declared surplus to the needs of the Corporation of the Municipality of Brockton;
- 3.0 That the Chief Administrative Officer and Clerk are hereby authorized and directed to execute all documents necessary on behalf of the Council to affect the disposition and to affix the corporate seal of the Corporation of the Municipality of Brockton to all such documents as required;
- 4.0 That this By-Law shall come into effect upon final passage.
- 5.0 This By-Law may be cited as the "PT LT 34 CON 1 NDR BRANT, PTS 9 & 10 3R-10640; S/T EASEMENT OVER PT 9 3R-10640; MUNICIPALITY OF BROCKTON, being PIN 33196 - 0616 (LT) and PT LT 34 CON 1 NDR BRANT, PART 1 3R-10027, MUNICIPALITY OF BROCKTON; being PIN 33196-0558 (LT) Surplus By-Law".
