5. ITEMS FOR DECISION/DISCUSSION

5.1 Polystyrene Densifier

- Bruce Davidson provided the Committee on the commissioning of the densifier and timelines as follows:
 - Staff training to commence May 1st
 - Start accepting styrofoam at the Hanover/Walkerton Landfill Site and Walkerton Recycling Depot as of May 15th
 - Operational launch and open house end of May at Walkerton Recycling Depot (date to be confirmed)

The Committee discussed polystyrene #6 meat trays and food containers which there will be test trials to determine feasibility of acceptance of this material.

5.2 Landfill Site Operator

- Ron Cooper advised that Jason Miskie has been hired for the landfill site operator position effective May 1st, 2019.

5.3 Household Hazardous Waste Events

5.4 Annual Monitoring and Reporting

- Ron Cooper advised that a request for proposal has been issued which closes April 30th, 2019.

5.5 Tree Planting along north Boundary

- The Committee reviewed the Mitigation Plan prepared by Stantec Consulting Ltd. for the landfill expansion which has been completed
- Additional larger trees were transplanted along the northerly boundary in 2018 which due to a wind storm no tall trees survived.
- The Committee agreed to replant the trees along the north boundary that did not survive.

6. ITEMS FOR INFORMATION/CORRESPONDENCE

6.1 Integrity Commissioner Training – May 1st

- Bruce Davidson and Chris Oberle confirmed that they have taken training through Brockton
- Gregg Furtney is registered for training as well as the Hanover Committee members.

6.2 Landfill Monthly Report

- The Committee reviewed the landfill monthly quantity report to March 31st, 2019 (see attached). It was noted that there was a decrease in residential quantities delivered to the site.

6.3 Landfill Operational Report

- The Committee reviewed the site operator's reports for January, February and March 2019 with no concerns.

6.4 2019 Landfill Budget

- The Committee reviewed the 2019 landfill budget status to March 31st, 2019 with no concerns.

6.5 Public Input on Reducing Litter and Waste

- The Committee reviewed a media release on Keeping Bruce-Grey Owen Sound Clean and Beautiful from Bill Walker, MPP regarding a discussion posted on the Environment Registry looking at ways to divert and reduce food and organic waste from households and businesses and increase opportunities for people to participate in waste reduction efforts.

6.6 Correspondence from Chris Oberle

- Chris Oberle provide information for discussion on the following items:
 1. Meetings of the Committee
 - The Committee agreed to hold meetings on a bi-monthly basis.
 2. Tree Berm
 - Trees to be replanted that did not survive along the north boundary.
 3. Residential Passes
 - Brockton Council expressed concerns and felt that the reinstatement of residential passes for Hanover residents should have been discussed at the Waste Management Committee. It was confirmed that Hanover would be paying the tipping fee for waste accepted through free passes as an additional cost to the municipality.

- The Committee discussed the recycling depot bins which through a tender process are currently provided by Waste Management of Canada until December 31st, 2020. This service will be reviewed prior to retendering.
