## **Recommendation:**

That the Council of the Municipality of Brockton hereby receives Report Number PW2019-23 - Cemetery Road Sidewalk Tender, prepared by John Strader, Roads Supervisor and approves a By-Law coming forward entering into the agreement with the Ministry of Transportation.

## **Report:**

## Background:

On February 12, 2018 Council raised concerns about the increased density and need for safe pedestrian travel along Cemetery Road and Yonge Street along Highway 9. It was determined the proposed sidewalk installation would be in the Ministry of Transportation Ontario's ("MTO") jurisdiction and the Municipality would be required to seek authorization from the MTO and further enter into an agreement. On March 12, 2018 Council agreed to proceed with engineering plans funded from the Capital Sidewalk Budget, and requested approval from the Ministry of Transportation.

#### Analysis:

The sidewalk will be installed on the south side of Cemetery Road between Yonge Street and the entrance of St. Teresa of Calcutta School in Walkerton. The Municipality will be responsible for designing and constructing the sidewalk to ministry standards, as well as all maintenance and repairs of the sidewalk including all illumination associated and the removal of debris, garbage, vegetation and snow.

The construction for installing the sidewalk on Cemetery Road is scheduled to be completed by September 2019.
