Report:

Background:

There has been an application put forth on lot 496 Lake Rosalind Road 4 for two residential dwellings to be built. (Bruce County Official Plan Amendment File #BCOPA236-18.34 and Municipality of Brockton Zoning Bylaw Amendment File #2-50-18.34). As part of the Planning Process, area residents were invited to make comment, in favour for or in opposition of, the application. The Lake Rosalind Property Owners Association and three (3) other local residents have written and submitted their comments and concerns through the process. Those letters are attached. One of those issues raised was about the ability of Well #1 and Well #3 to handle the additional demand (water consumption) that these two (2) new residential homes will have for potable water.

Analysis:

In response to the concerns from residents related to this specific issue, staff have reached out to both Veolia North America (currently the Operators of the Lake Rosalind Water System) as well as a Lotowater Technical Services Inc. (who have performed repairs and service on the Lake Rosalind Wells since 2003) to get their opinion on whether or not the current potable water system, including the Wells, would have the ability and capacity to handle two additional residential hookups. Staff from both organizations note that there is

capacity for the two (2) additional residential hookups. Please see the attached letter from Lotowater Technical Services as well as the report they were commissioned to write in December of 2018 related to the Lake Rosalind Water Supply.
