Report:

Background:

The Brockton Economic Development Committee (EDC) sought a more expansive and detailed terms of reference to guide its actions and help define its mandate as a Committee of Council. EDC asked the Community Development Coordinator and Committee Chairman to draft new Terms of Reference for consideration. The new Terms of Reference were presented and approved by the Economic Development Committee.

Analysis:

The new Terms of Reference for Brockton's EDC specify a broader mandate that includes community development. "The committee's mandate is to support and expand the range of business, trade and industry within the Municipality of Brockton and to encourage community development that enhances the quality of life of people currently working and living in the community, as well as future residents."

The Terms of Reference specify ways to facilitate the orderly development and expansion of business, trade and industry and outlines the duties and responsibilities of its members. The Terms of Reference were approved by the EDC in April 2019, and have been reviewed by Brockton's Chief Administrative Officer.

Staff are seeking Council's adoption of the EDC Terms of Reference by By-Law.
