### **Recommendation:**

That the Council of the Municipality of Brockton hereby receives Report Number FIN2019-20 - Speed Hump Funding, prepared by Trish Serratore, Chief Financial Officer, and in doing so approves that the funding of the speed hump and signage be taken from the Brockton Police Reserve Fund.

### **Report:**

#### **Background:**

At the March 26, 2019 Council Meeting, Council directed staff to review pricing for speed deterrent devices, specifically removable speed humps.

At the May 28, 2019 Council Meeting, John Strader, Roads Supervisor presented Report Number PW2019-24 - Speed Deterrent Pricing. Council passed Resolution 19-12-11 approving the report, and provided staff with the direction to purchase two speed humps. John Strader, Roads Supervisor also identified that the Operations Department would also require appropriate signage to accompany the speed humps to notify residents of the speed humps along the roadways.

#### **Analysis:**

Staff recommend that the speed humps and signage be funded by the Brockton Police Service Board in a similar manner as the Black Cat Radar that was purchased in 2018.

The Brockton Police Service Board did not include this purchase in their 2019 budget; however, funding is available within the Brockton Police Reserve Fund. Currently, the balance in the reserve fund is \$157,754. Staff recommend that it would be the most beneficial to fund the purchase of the two speed humps out of this account.

The Brockton Police Service Board considered this matter at their meeting on May 30, 2019, and approved funding the purchase of the speed humps and signage out of the Brockton Police Reserve Fund.




