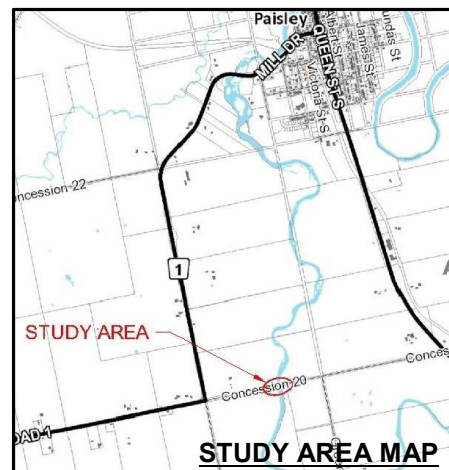


MUNICIPALITY OF BROCKTON
BRIDGE No.11 (GREENOCK): CONCESSION 20
MUNICIPAL CLASS ENVIRONMENTAL ASSESSMENT
SCHEDULE 'B'
NOTICE OF COMPLETION

The Municipality of Brockton is advancing project specific planning to address the deteriorated condition of Bridge No.11 (Greenock) south of Paisley, on Concession 20 between Baseline North and Greenock Elderslie Road, where shown on the Study Area Map. The Municipality has identified various deficiencies with the bridge, including deficient road approaches, severe section loss at the floor beams and stringers and severe corrosion throughout. The project is being planned under Schedule 'B' of the Municipal Class Environmental Assessment, as outlined in the Municipal Class Environmental Assessment Manual prepared by the Municipal Engineers Association (2015). Alternative solutions that were considered for the structure included the following:

1. Do Nothing;
2. Bridge Rehabilitation;
3. Bridge Replacement;
4. Bridge Removal; and
5. Bridge Retention/Adaption.



Based on the *Preferred Solution* accepted by Council on May 28th, 2019, the Municipality intends to proceed with the removal of Bridge No.11. Documentation of the development and review of the alternatives considered, including a summary of the planning and consultation process, a detailed evaluation and assessment of the alternatives and the rationale for the selection of bridge removal as the *Preferred Solution*, is provided in Version 3 of the Project File (June 2019), which is available on the Municipality's website.

This Notice initiates the 30 calendar day Public Review Period. Interested persons should provide written comment within 30 days from the date of this Notice to the Municipality of Brockton and/or GM BluePlan Engineering.

If concerns arise regarding this project, that cannot be resolved through discussions with the Municipality, then members of the public, interested groups or technical agencies may request the Minister of the Environment, Conservation and Parks (MECP) to issue a 'Part II Order' for the project. Within the Part II Order request, the Minister may be requested to refer the matter to mediation, impose additional project conditions, and/or request an elevated scope of study (i.e. an individual environmental assessment). A Part II Order request requires the completion of a 'Part II Order Request' Form (Form ID No.012-2206E), which can be found on Service Ontario's website (<http://www.forms.ssb.gov.on.ca/>).

Requests may be received by the Minister at the address below within 30 calendar days of this Notice. A copy of the request must also be sent to the Director of the Environmental Assessment and Permissions Branch (MECP) and the Municipality of Brockton. If there is no request received by July 4th, 2019, the project will proceed to detailed design and construction.
