Report:

Background:

In March 2019, the Municipality of Brockton issued a Request for Proposals (RFP) to undertake a detailed Recreation Facility Needs Assessment of the Walkerton Community Centre and The Centennial Pool. Staff presented Report Number REC2019-06 – Building Condition Assessment Quotations at the March 26, 2019 Council Meeting providing information about the project.

At the March 26, 2019 Meeting, Council awarded the RFP's for the Building Condition Assessment of the Walkerton Community Centre and Centennial pool Facility to The Pinchin Group.

The Needs Assessments were completed in May 2019.

Analysis:

Attached are seven reports outlining the Building Condition Assessment, the Accessibility Audit, Hazardous Building Materials Assessment, and Condition Assessment of Mechanical and Electrical Systems for both the Walkerton Community Centre and Centennial Pool for Council's review.

The Pinchin Group are attending the August 13, 2019 Council Meeting as a delegation to present a summary of the Building Condition Assessments.
