Report:

Background:

On June 4, 2019, staff presented Council with Report Number CLK2019-11 – Grey Bruce Sound and Lighting Equipment, detailing the state of sound and lighting equipment utilized by the Grey Bruce Sound and Lighting Consortium, upon receiving a letter from Grey Bruce Sound and Lighting asking that the equipment be donated to the Knox Presbyterian Church. Grey Bruce Sound and Lighting were also present at the June 4, 2019 Council Meeting as a delegation. Council passed Resolution 19-13-09 approving that the equipment be donated to the Knox Presbyterian Church.

Staff sent a letter to Grey Bruce Sound and Lighting on June 5, 2019, informing Grey Bruce Sound and Lighting of Council's decision to donate the equipment. This letter has been attached for Council's information.

Analysis:

Staff received a follow-up letter from Grey Bruce Sound and Lighting on July 8, 2019 which has been attached to this report for Council's information.

Grey Bruce Sound and Lighting are needing to replace portions of the donated equipment, and are now requesting that Council transfer the remaining funds of the Bruce Grey Light/Sound Collaborative account to Knox Presbyterian Church in order to maintain the equipment.

Staff is requesting further direction from Council on how to proceed with this financial request.
