That the Council of the Municipality of Brockton hereby accepts Report Number DRAIN2019-02 – Appoint Engineering Company for Koelen Municipal Drain, prepared by Stephen Cobean, Drainage Superintendent, and in doing so approves a By-Law coming forward appointing Dietrich Engineering Limited as the Engineering Company for the Koelen Municipal Drain.

Report:

Background:

Dietrich Engineering Limited, located at 10 Alpine Court in Kitchener, has many years of experience dealing with Agriculture Drain Improvement projects under the *Drainage Act, R.S.O. 1990, c. D.17*.

Dietrich Engineering has considerable experience dealing with the agriculture drainage conditions of Bruce County. Dietrich Engineering also has considerable experience dealing with the requirements of the various government agencies, namely the Saugeen Valley Conservation Authority, Ministry of Natural Resources and Forestry, Ministry of Agriculture, Food and Rural Affairs, Ministry of the Environment, Conservation and Parks, the Federal Department of Fisheries and Oceans, and all Statutory Acts pertaining to these agencies, that relate to Agriculture Municipal Drainage.

Analysis:

R.J. Burnside Engineering, located in Wingham, is an alternative Engineering Company that could be appointed as the Engineering Company for the Koelen Municipal Drain.

However, Dietrich Engineering has been used by the Municipality of Brockton in the past and has been a valued engineering company. I recommend that the Municipality of Brockton appoint Dietrich Engineering for the Koelen Municipal Drain.

Staff have prepared a By-Law to appoint Dietrich Engineering Limited as the Engineering Company for the Koelen Municipal Drain.


