Report:

Background:

On March 27, 2019, The Municipality of Brockton publicly invited proposals for the procurement of a qualified and competent Consulting Engineering Firm to complete a Municipal Rural Roads Condition and Needs Assessment Study (399 Kilometers of road).

The scope of the project study was to provide the Municipality with a comprehensive Rural Roads Condition and Needs Assessment that will inform the Municipality's Capital Asset Management Plan and guide future Capital Project planning (0 to 5 year, 6 to 10 years, and 11 to 20 years). The successful proponent for this project was B.M Ross and Associates.

Analysis:

The final report is attached. A representative of B.M. Ross and Associates are attending the September 10, 2019 Council Meeting as a delegation to present, from their study, a summary of their findings and recommendations.

Staff recommends that the outlined recommendations be considered in future Municipal Budget discussions and be implemented, as is suggested by B.M. Ross and Associates, in a Roads Management Master Plan.
