### Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number PW2019-38 – Removal of Bridge 11 Greenock Tender, prepared by Gregory Furtney, Director of Operations, for information purposes and further approves a By-Law coming forward authorizing and awarding the project to Owen King Limited for \$184,115 plus H.S.T.

### Report:

#### Background:

At the May 28, 2019, Brockton Council Meeting, Council passed Resolution 19-12-07 authorizing the removal of Bridge 11, Greenock.

After that meeting, GM BluePlan Engineering was directed to prepare and issue a “Tender Advertisement”, which included scoping the project, for the removal of Bridge 11, Greenock. The Tender Advertisement was forwarded to eight (8) local construction and excavating companies and was posted on Brockton’s Website. The Tender closed on Friday September 6, 2019 at 11:00 a.m.

Three (3) companies provided a tender submission. One (1) company submitted after the deadline.

After Brockton Staff opened and reviewed the tender submissions, staff at GM BluePlan were tasked with reviewing the submissions for accuracy and asked to provide the Municipality of Brockton with a letter of verification which included a formal recommendation.

Construction is anticipated to commence by September 23, 2019 and be totally completed by Friday, November 1, 2019.

### **Analysis:**

Staff have reviewed the recommendation from GM Blue Plan's recommendation and agree with awarding the contract to Owen King Limited in the amount of \$184,115 plus H.S.T.
