Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number FIRE2019-03 - Vacant Buildings By-Law, prepared by Mike Murphy, Fire Chief and Terry Tuck, Chief Building Official and further approves a By-Law coming forward.

Report:

Background:

It has been recognized that vacant or abandoned buildings/structures can potentially attract criminal activity and become a threat to public safety. Unfortunately, there are some vacant buildings throughout the Municipality of Brockton, both in urban and rural areas that have been left vacant for some time.

These vacant buildings pose a safety hazard to all of the general public, as they pose a fire hazard which could potentially cause damage to other neighbouring properties.

Analysis:

Vacant buildings/structures that are not secure and open to unauthorized entry have a high probability of intentionally set fires. When fires occur in these buildings, they present a host of unusual problems to firefighters. Since the buildings are uninhabited, fires may develop for significant periods of time before they are detected and reported.

Firefighters may encounter open shafts, stairways, pits or holes in floors that would not be found in occupied structures. All of these factors contribute to the danger these structures pose to firefighters operating in them.

The removal of equipment or structural components and deterioration of the building due to age or weather can weaken the structure creating the potential threat to public safety due to the collapse of portions of the building, falling debris or rapid structural failure early in a fire.

Staff have prepared a By-Law to regulate vacant buildings in the Municipality of Brockton. The draft By-law would require owners of vacant properties to take reasonable precautions to prevent acts of vandalism or fire. If, in the opinion of the Fire Chief, Chief Building Official or By-law Enforcement Officer reasonable precautions have not been adopted, a letter would be sent outlining the requirements for the property owner. If no steps were taken, the Municipality of Brockton could make arrangements for the steps to be taken (such as windows boarded up, etc.) and recouperate the costs of such expenses by adding them to the property taxes.
