### **Report:**

### Background:

The Municipality has not previously had a Cell Phone or Mobile Device Policy. With the transition of staff having a clear and concise policy with expectations established upon acceptance of a Municipal issued Cell Phone is essential.

#### Analysis:

I have attached a new Cell Phone/Mobile Device Policy. This Policy has had extensive review in relation to other municipal policies, solicitor input based on best practices today and considerations related to some personal cell phone use, staff transitions and best practices related to IT and retrieval of municipal information to ensure information is preserved for MFIPPA disclosure requirements, and to ensure compliance with applicable laws and regulations.

I have also brought forward the Information Technology Acceptable Use Policy for a slight update to ensure both policies are worded in unison regarding the expectation that the Cell Phone/Mobile device is provided primarily for business use but there is room for personal use within reasonable limits so long as it does not interfere or conflict with business use. I recommend a By-Law be brought forward for consideration of the proposed Cell Phone/Mobile Device Policy.
