Background:

Dan Gieruszak, Deputy Mayor and Sonya Watson, CAO represent the Municipality of Brockton on the Regional Liaison Committee hosted by Bruce Power, Bruce County and the Organization of Canadian Nuclear industries (OCNI).

Analysis:

On October 4, 2019, Dan Gieruszak, Deputy Mayor and Sonya Watson, CAO attended the Bruce Power Visitor Centre for the Regional Liaison Committee Meeting. Many representatives from Bruce, Grey and Huron County attended, as well as some members of the Provincial Government.

The 6 month outlook from the meeting is attached and was reviewed at the meeting.

Overall, the meetings are very worthwhile to attend; James Scongack- Bruce Power, Alison Fernandes- Bruce County/Bruce Power/OCNI, Kara Van Myall-County of Bruce and Ron Oberth- OCNI provided project updates from their organizations and each attendee had the opportunity to provide their own community or organization update. Of note, James Scongack reminded everyone of the need for Bruce Power and its Suppliers to remain vigilant and efficient throughout the MCR project, as the Province has opportunities to pull-out of the project at certain milestones. This led to discussions of the need for innovation and organization efficiency that all the participants should be striving for in their organizations; especially with the help of the NII and the Municipal Innovation Council.

The need for housing and transportation throughout the area was also a reoccurring topic at the meeting and the infrastructure plans to support development being initiated by many municipalities across Bruce County.
