

...the way municipalities do business. We will evolve through shared strategy and approach, and we will celebrate what works (and what doesn't).




# MUNICIPAL SUSTAINABILITY

# INFORMATION TECHNOLOGY AND DIGITAL ENHANCEMENTS


Learning from others’ expertise to deliver innovative digital solutions

As the host community of Nuclear Innovation Institute, the Town of Saugeen Shores will chair the MIC.

Acting as the lead for the MIC, a Saugeen Shores representative will coordinate strategic goal setting, priority planning, and will work to ensure a shared understanding and responsibility.

Supported by a dedicated MIC-funded staff person, Saugeen Shores will coordinate the agreement of members to advance priority items and will ensure membership agreement in financial decisions.

The Town of Saugeen Shores will coordinate guests and events, and will facilitate actions through the direction of the MIC.

Each contributing municipality will be a member of the MIC. As members, each organization can designate an innovative, collaborative and engaged person to participate.

The MIC will rely on municipal staff to work with each other and with external innovators to learn, collaborate and transform the way municipalities do business.



## AGREEMENT

The Municipal Innovation Council (MIC) is a key priority and deliverable of Nuclear Innovation Institute (NII). As such, NII will provide resources and support to partners of the MIC.

This will be set out in a partnership Memorandum of Understanding (MOU) between NII and the Town of Saugeen Shores that outlines the MIC mandate, principles for advancing that mandate, and the roles and responsibilities of NII and Saugeen Shores.

NII will support and engage with MIC, providing space, resources for Innovation Teams and access to industry leaders. As host community, the Town of Saugeen Shores will have an ex-officio seat on NII's Board of Directors to remain connected and engaged in overall NII operations and projects.

Potential members of the MIC will enter into an MOU with the host community as MIC lead. The MOU between the contributing member and NII/host community will also outline roles, responsibilities and expectations.
