### **Recommendation:**

That the Council of the Municipality of Brockton hereby receives Report Number FIN2019- 36 – Twice the Ice Zamboni Donation Request, prepared by Trish Serratore, Chief Financial Officer for information and approves the donation of the Zamboni to Walkerton Minor Hockey Association (WMHA); and authorizes an exemption to the Surplus Asset Policy to donate the equipment.

### **Report:**

### Background:

In 2002, The Municipality purchased the Zamboni, model 440 for \$60,320. This machine is beyond its useful life and was replaced with an Olympia in 2014.

The Municipality has entered into an agreement with the Twice the Ice Volunteer Committee for the use of the 2002 Zamboni. By-law 2016-042 is the most recent agreement which expired in March 2019. The Twice the Ice Volunteer committee, in partnership with Walkerton Minor Hockey Association have used and maintained the Zamboni for the second ice surface located at the Walkerton Agricultural Building.

#### Analysis:

On October 23, 2019, staff received a request from the Twice the Ice Volunteer committee, along with the support from Walkerton Minor Hockey Association for the donation of the equipment. The Surplus Asset Policy, F06-0500-18 has been attached for Council's reference.

Staff have determined that the Zamboni is surplus equipment and it is used for the maintenance of the second ice service which is operated and managed solely by the volunteer committee. Since this equipment is being

used by a volunteer group, it is our recommendation that Council approves the donation of the equipment and approves an exemption from the Surplus Asset Policy, F06-0500-18.

Staff also recommend a simple, revised Memorandum of Understanding ("MOU") with the Walkerton Minor Hockey Association, as the old MOU has expired. The revised MOU anticipates that Brockton will continue to provide blade sharpening, propane for the Zamboni and hydro and bill these costs back to the Walkerton Minor Hockey Association. The MOU also states that the Municipality of Brockton would be able to use the Zamboni in emergency situations (such as if the Olympia needed repairs).
