Some members of Council also discussed whether residents would view the proposed information bulletin as a capitulation and felt that the information bulletin did not give residents any sense of a potential solution.

Council also considered whether a town hall meeting would be a better avenue to show residents Council's commitment to finding a solution. Council confirmed that Walkerton District Community School be provided the opportunity to decide whether the information bulletin should be distributed solely by Brockton, with Mayor Peabody, Councillor Adams and Councillor Lang hand delivering the information bulletin.

Action: The Information Bulletin be amended to diplomatically remove the logo of the Grey Bruce Health Unit and offer to host a Town Hall Meeting (inviting affected residents and students) at a date to be determined.
