Report:

Background:

On October 29, 2019, staff brought forward Report Number ED2019-11 – Walkerton 2020 Commemoration providing Council with information about the formation of a committee to assist staff in hosting a municipal event to commemorate the 20th anniversary of the Walkerton water tragedy. Council passed Resolution 19-22-07 endorsing the formation of the committee.

Staff have begun advertising for individuals to join the Walkerton 2020 Ad Hoc Committee. The advertisement was posted in the Walkerton Herald Times, Hanover Post, Cargill Area News, municipal website, and social media. Interested individuals have been asked to submit a brief description of their interest in the committee by Wednesday, December 11, 2019 to Community Development Coordinator, Paulette Peirol by email or mail.

Staff have prepared a Terms of Reference for the Walkerton 2020 Ad Hoc Committee which has been attached to this report for Council's review. Staff are recommending that the Terms of Reference be adopted by By-Law and that Mayor Peabody and a Councillor be appointed to the Committee.
