# 14. New Business Brought Forward

#### 1. Economic Development Forum

Deputy Mayor Gieruszak informed Council that he had attended an Economic Development Forum in a community near the Darlington nuclear plant (the Town of Clarington), which was experiencing challenges related to growth. The Town of Clarington also had a university focusing on skilled trades and a strong agricultural sector. Deputy Mayor Gieruszak noted the innovation occurring in that community and the knowledge that could be shared with Brockton given the similarities between the communities.

#### 2. Traffic and Intersection of Durham Street and McNab (near Tim Hortons)

Gregory Furtney, Director of Operations, informed Council that the County of Bruce was proposing a new timeline for the project, as the original consultant did not provide the information the County of Bruce was anticipating and the project had been re-scoped. The study would not be simply a review of the crosswalk, but a more fulsome study of pedestrian traffic.

#### 3. Soccer Fundraising Committee

Mayor Peabody noted that monies would be forthcoming that may build momentum. There was a commitment from other members although the Committee has not yet had a chance to meet.

# 4. Christmas Party and Santa Claus Parade

Mayor Peabody thanked staff for the Christmas Party, and reminded Council about the Brockton Santa Claus Parade occurring on Saturday, November 30, 2019 in Walkerton at 6:30 p.m.

# 5. Nuclear Waste Management Organization (NWMO)

Three sites are still in the running for the location of the Nuclear Waste Management Organization's long-term management of used nuclear fuel. Those sites include: the Township of Ignace, the Municipality of South Bruce, and the Township of Huron-Kinloss.

# 6. Russell Municipal Drain

The Agriculture, Food, and Rural Affairs Appeal Tribunal for the Russell Municipal Drain informed staff that the appellant has withdrawn the appeal, and the Hearing originally scheduled for November 28, 2019 has been cancelled.
