## By-Law 2019-147

---

### Being a By-Law to Increase the Fees for Building Permits in the Municipality of Brockton.

---

**Whereas** Section 7 of the *Building Code Act*, S.O. 1992, C.23, as amended, empowers municipal councils to pass by-laws respecting construction, demolition and change of use permits and inspections; and;

**And Whereas** Section 7(c) of the *Building Code Act*, S.O. 1992, C23, as amended authorizes a municipality to require the payment of fees on applications and issuance of permits and prescribe the amounts thereof; and;

**And Whereas** the *Municipal Act*, 2001, Chapter 25, Section 391(1) authorizes a municipality to impose fees or charges on any class of persons,

- a) for services or activities provided or done by or on behalf of it;
- b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and
- c) for the use of its property including property under its control.

**And Whereas** Municipal Councils have the authority to establish rates and fees under various Acts, and the Council of the Corporation of the Municipality of Brockton deems it expedient to pass a by-law establishing an increase in building permit fees;

**Now Therefore** the Council of the Corporation of the Municipality of Brockton **Enacts as Follows:**

- 1.0 That Schedule "D" to By-law 2008-02, the Building By-law, be replaced by schedule attached hereto and identified as Schedule "A" to this by-law and it shall form an integral part thereof.
- 2.0 That By-law 2011-15 – Building By-law – Permits and Fees is hereby rescinded.
- 3.0 That this By-Law shall come into effect on January 1, 2020.
- 4.0 This By-Law may be cited as the "Approve Building Permit Fees By-Law".
