### **Report:**

### Background:

Community donation plaques are displayed at the Bruce County Public Library, Cargill Library Branch when donations are made by individuals towards the Cargill Library. The plaques are approximately 1 ¾ inches by 6 1/2" inches. A photo of the current plaques have been attached to this report for Council's information.

The Brockton Heritage Committee received an inquiry from an individual who wishes to purchase an additional plaque for their donation to the Cargill Library Branch. The last Cargill Library Branch plaque was likely purchased sometime in the late 90's. The request to purchase a plaque is interesting because it also coincides with a number of months of steadily increasing users and programming at the Cargill Library Branch.

#### Analysis:

Staff have inquired with Cox Signs Limited and obtained a quote for the approximate cost of a similar plaque. Staff are proposing that the individual pays the cost of the donation plaque, as well as a minimal administration fee for staff time involved in the organizing of the process to be included in the 2020 Fees and Charges By-Law.
