1. Motion Supporting Bill 156 Security from Trespass and Protecting Food Safety Act, 2019

Mayor Peabody provided Notice of a Motion to be considered at the next Council meeting. According to Mayor Peabody, Brockton had the highest agricultural output in Bruce County and he emphasized the importance of supporting the agricultural sector.

2. Fischer Dairy Road and Hinks Street

Councillor Adams provided Notice of a Motion to be considered at the next Council meeting that the Municipality of Brockton become more involved in the student smoking issue at the intersection of Hinks Street and Fischer Dairy Road.

3. Natural Gas Survey

Councillor Lang noted that some residents were concerned with the targeted area of the survey and he encouraged Council and staff to communicate that the survey was only an initial planning tool that did not preclude potentially extending the service to areas outside the survey limits in the future.

4. Rural Ontario Municipal Association Delegation

Fiona Hamilton, Clerk informed Council that two delegates on behalf of the Municipality of Brockton were invited to speak in a roundtable relating to the provision of natural gas. The Office of the Solicitor General also agreed to meet to discuss the prisoner transportation and court security grant. No response had been received from the Minister of Health relating to the final request that had been made to discuss the birthing unit at the Walkerton Hospital.

- A position, plan, procedure, criteria or instruction to be applied to any negotiation carried on or to be carried on by or on behalf of the municipality or local board
- The meeting is held for the purpose of educating or training the members and at the meeting, no member discusses or otherwise deals with any matter in a way that materially advances the business or decision-making of the council, local board or committee.
