Dear Members of Council,

Please accept this as a letter of intent and application for the vacant Brockton councillor position.

I am a proud resident of Walkerton (Brockton) after having moved here from the GTA to seek employment as an educator some 26 years ago. When I first moved to the area, I thought that it was only temporary and I would eventually make my way back home to seek further employment, however, as I eased into my new surroundings, I became enthralled with the community in its beauty and sense of belonging and made the decision to settle here permanently. Subsequently, I married and had a family that calls this part of Bruce County home. I am grateful that I live in Brockton. In this way, I wish to serve the Brockton community and to seek the councillor position as a way of giving back to a community that offers so much to others.

I am an active Brockton resident, working to help make our community a better place. I have been a member of the Tree Committee, the Walkerton Healthy Community Initiative, and the Curling Club executive. More recently, I was a member of the Steering Committee for the Walkerton 2016 'Catch the Spirit' Homecoming and the current Sesquicentennial Birthday Committee for 2021.
