Background Information

I am a retired educator having worked for 11 years in the public system in Toronto and 20 years more at Upper Canada College. The latter was a particularly different and far richer teaching experience. I immediately was given the responsibility of rejuvenating the physics program and given a substantial budget to do so. I then became chair of science. Soon I was also asked to oversee all aspects of the residential program for international and national students. I initiated a national program for people involved in residential programs, both across Canada and the USA. The focus of the conference was on how to deliver a values education to the students.

Because some of my classroom work had garnered some attention, I was asked to present to the Science Teachers' Association of Ontario and did this for over 20 years, the final one resulting in being awarded a Scholar Award for which the Minister of Science and Technology gave me a special citation for my contribution to science education. I also presented to a number of other professional organizations and did contracted work both within and outside the College on a regular basis.

Finally, UCC adopted the International Baccalaureate program and I was asked to write curriculum for a new course and to be its chief examiner. This was a real honour for me and a coup for the school. The result of my professional involvement was first national and international recognition for my work. When I retired UCC named a physics prize in my name and is presented annually to the top physics student at the College.

The basic take-away from the above is that it illustrates my capacity for diversity, commitment to life-long learning and a capacity to do far more for my students at a very high level.

Since moving to Bruce County I have been fully immersed in the community and have volunteered my services on a number of fronts. First and foremost my wife and I have rescued and modernized over 5,000sq.ft. of our building and have created a small business that is now a major tourist destination in the County.

Community Service Involvement (chronological)

Accommodation Review for Paisley Central School (2,000 – 2,003 and 2018 -2019)

I successfully defended the need for this school to remain open on both occasions and was an integral part of the community in doing so.

Paisley & District Chamber of Commerce

Was a member from 2002 – present and acted as president from 2,004 -2 006

Lake Huron Shoreline Tourism Marketing Partners

I have been a member since 2003 to the present and the Chair from 2009 to the present. The group spanned from Point Clark on the south to Sauble Beach on the north and included Lucknow, Ripley and Paisley. The composition of the committee included councillors from each municipality, tourism operators from Huron-Kinloss, Kincardine, Saugeen Shores, Arran-Elderslie, Bruce Power, Bruce County Museum, Southampton Art School and Gallery, associated Chambers of Commerce, MacGregor Point Provincial Park. Every year this group promoted and marketed this area to increase tourism revenues through the development of core trip motivators for tourists and full-time residents.

Intensive Livestock operations in Bruce County and Canada

This included presentations of scientific findings of the environmental impact of ILO's and in the end gave input at the provincial level when developing a nutrient management act. A spin-off from this was to advise the federal government on the Great Lakes Water quality and preservation.

Region 7 Tourist Organization (RTO7)

This organization was one of 13 set up by the Province of Ontario and consisted of Bruce, Grey and Simcoe counties. With the expected increase in tourism both nationally and internationally these organizations were established to increase tourism revenue by 20%. As such they received provincial funding to do so. A board of directors was established in January of 2010 after a substantial selection process for the board members and following this an executive was voted on at which time I was elected as president, a position I held until 2015 when I resigned from the board to move on to other things.

Physician recruitment & retention and BAFHT

I have assumed that my being awarded a volunteer service award by the MTCAS this year was because of my long standing service in these two areas. I ceased working with the recruitment committee to devote my time to starting up the Walkerton and Area Family Health Team. I was a founding board member and acted as president of the FHT. I left the board while serving RTO7 to avoid being caught in a divided loyalty situation. When I left RTO7 I went back to serve on the FHT board.

Walkerton BIA

I was a member of the board for several years and served as president when the board reformed 2 years ago.
