Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number PW2020-01 - Resident Request for an Easement and to Dig in the Municipal Right of Way – Egypt Side Road, Greenock, prepared by Gregg Furtney, Director of Operations and further grants approval for the Municipality of Brockton to enter into a legal Easement Agreement with the resident; and further grants the contractor permission to dig within the Municipal Right of Way to allow for a residential Hydro One hookup.

Report:

Background:

In late December of 2019, a local resident from Egypt Side Road, Greenock, had requested and paid for plans, provided by Hydro One, for a new residential electrical hookup onto his property. The property is located in an area that would otherwise not have electrical service and the building currently uses solar panels for electricity. In order to provide this opportunity to the resident, based on the Hydro One project plans, the Municipality of Brockton must grant an Easement to the property owner and also give permission to the resident/ property owner for them, Hydro One, or their contractor, to dig within the Municipal Right of Way.

Analysis:

These plans were drawn up by Electrical Engineers who specialize in Hydro One related projects. The plans are paid for by the resident. Costs associated with the Easement Agreement are also paid for by the resident. The Public Works Department has no concerns with regards to this project. Cost, Risk, and Liability are born by Hydro One, the Contractor, and the Resident. A resolution of Council is needed to move the project forward.
