Report:

Background:

On December 3, 2019, staff brought forward Report Number CLK2019-41 describing the various amendments that have been made to the current Traffic and Parking By-Law 2012-40. Staff consolidated the amendments into a draft By-Law.

Analysis:

Staff advertised for public comments on the following new provisions within the proposed Consolidated Traffic and Parking By-Law:

The Municipality is inviting the public to provide comments on the proposal to prohibit parking at Lake Rosalind, and the change to Winter Parking Restrictions, to prohibit parking on all highways in Brockton from 2:00 a.m. to 6:00 a.m. during the months of November, December, January, February, March, and April.

The advertisement for comments was included in the January, February, and March 2020 editions of the Brockton Buzz Newsletter, and on the municipal website and social media accounts.

All residents (seasonal and local) within 120 metres of Lake Rosalind and Marl Lakes were also mailed a letter requesting their comments, and copy of the Consolidated Traffic and Parking By-Law.

Comments were received until March 2, 2020 at 12:00 Noon.

Approximately twenty-two (22) public comments were received, and have been summarized below for Council's information:

Based on the comments received to date, residents did not have significant concerns regarding parking restrictions at Lake Rosalind or Marl Lakes.

Additional Traffic and Parking Matters:

Additional items have arisen in the past few weeks, which would require staff to draft additional clauses for enforcement within the Consolidated Traffic and Parking By-Law.

As a result of the invitation for public comments a suggestion was also made to include a Crosswalk Designation at Hinks Street to Cemetery Road in order for residents to access the Child Care Centre and schools with increased traffic heading into the Fischer Dairy Road Subdivision. Upon consultation with Roads Supervisor, John Strader, the designation would be an estimated cost of \$15,000-18,000, which was not included in the 2020 Budget. Further, investigation including traffic counts and an analysis of the intersection would need to be obtained if Council desired to move forward with this installation prior to including the provision in the Consolidated Traffic and Parking By-Law. Staff require further direction from Council if they wish to proceed on this matter.

A further parking matter arose recently in relation to downtown parking, and long-term parking. Staff will be reviewing the clauses regarding long-term overnight parking, and/or camping in municipal parking lots. Provisions are needed to support enforcement efforts.

The draft By-Law from December 3, 2019 is attached to this report, which is the By-law version that was sent out for public comments. Based on Council's input a revised draft will be brought forward to the March 24, 2020 Council Meeting.

It should be noted that after Council approves the Consolidated By-Law, the By-Law still requires approval from the Attorney General, which can take up to six (6) months to approve the short-term wording and set fines. The current Traffic and Parking By-Law 2012-40 would still be in effect until the new Consolidated By-Law is approved by the Attorney General.
