That the Council of the Municipality of Brockton hereby receives Report Number FIN2020-12 – Green Municipal Fund Walkerton Pollution Control Plant UV Disinfection System Loan/Grant Agreement, prepared by Trish Serratore, Chief Financial Officer, and in doing so approves a By-Law coming forward to accept the loan and grant agreement with Green Municipal Fund for Project GMF16598 for the Walkerton Pollution Control Plant UV Disinfection System.

### Report:

#### **Background:**

On October 17<sup>th</sup>, 2019 staff received notification that they were approved for the Federation of Canadian Municipalities (FCM) Green Municipal Fund combined loan and grant application for the Walkerton Pollution Control UV Disinfection System.

On March 10, 2020 Council accepted the tender for the Walkerton Pollution Control Plant UV Disinfection System Project authorized by By-Law 2020-026.

#### **Analysis:**

On February 19, 2020, staff received the attached agreement from the FCM for the combined loan and grant application. With the recent acceptance of the tender, staff now require authorization from Council to enter into the agreement as attached. The FCM loan offers below-mark loans and is combined with a grant. The total approved loan is up to \$520,000 with a grant of up to \$78,000.
