6.2 By-Law 2020-032 - Pandemic Delegation of Authority By-Law

Some members of Council emphasized the importance of continuing to meet in early April, even if electronically, to demonstrate Council's commitment to oversight for Brockton residents. Fiona Hamilton, Clerk, described the degree of uncertainty related to the new legislation released earlier in the afternoon, and the need to consider how to organize electronic meetings that would still be accountable and transparent to the public. Ms. Hamilton also emphasized the paramountcy of maintaining physical distancing to assist in reducing the spread of Covid-19 and the measures to be taken to ensure minimal service disruptions for residents.

Council amended By-Law 2020-032 to clarify that Council intended to make use of the electronic participation provisions introduced by the Province of Ontario in Bill 187 for emergency pandemics to the greatest extent possible.
