

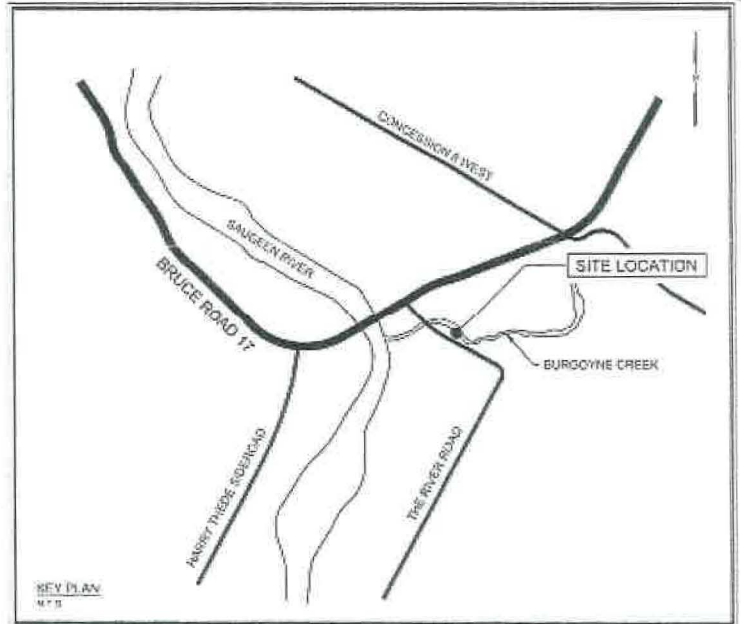
**Notice of Study Completion  
Municipal Class Environmental Assessment  
Schedule B Environmental Study**

**The River Road Bank Stabilization, Town of Saugeen Shores**



**The Study**

The Town of Saugeen Shores has completed a Municipal Class Environmental Assessment (MCEA) that considered options to address the erosion of the slope between The River Road and Burgoyne Creek. Options included bank or slope regrading, slope stabilization, relocation, realignment or channelization of the watercourse. The preferred solution is to Protect the Creek Bank in Place through slope regrading and stabilization. The site location and approximate extent of the Study Area are shown on the map.



**The Process**

The Study followed Schedule B of the *Municipal Class Environmental Assessment* process (Municipal Engineers Association, October 2000, as amended in 2007, 2011, & 2015), which is an approved process under the *Ontario Environmental Assessment Act*.

The Study evaluated alternative solutions with consideration of the natural, cultural, technical and economic environment. A Notice of Commencement inviting public input was published on May 14 and May 21, 2019.

**Project File Report**

A Project File Report (PFR) has been prepared to document the planning and decision-making process for this Study. By this notice, the PFR will be placed on the public record and be available for a 30-day review period starting **March 3<sup>rd</sup>, 2020** and ending **April 2<sup>nd</sup>, 2020** in accordance with the requirements of the MCEA process. If concerns arise regarding this Study which cannot be resolved through discussion with the Town of Saugeen Shores, the person or party with the concern may submit a written request to the Minister of the Environment, Conservation and Parks to make an order for the Study to comply with Part II of the *Environmental Assessment Act* (referred to as a Part II Order), which addresses Individual Environmental Assessments. Part II Order Requests must be submitted using a standard form available on the Provincial Forms Repository website (<http://www.forms.ssb.gov.on.ca/>). The form can be found by searching either "Part II Order" or "012-2206E" (the form ID number) on the Repository's main page. The completed form for Part II Order Request must be received by the Minister by 4:30 p.m. on **April 2<sup>nd</sup>, 2020** and a copy of the completed form should also be sent the Director, Environmental Approvals Branch (addresses are provided on the bottom of the form) and to the Town of Saugeen Shores Project Team by this time and date. If no request is received by **April 2<sup>nd</sup>, 2020**, the Town of Saugeen Shores intends to proceed with detailed design and construction as outlined in the PFR subject to Provincial agency approval and Municipal priorities and budgets.

Project and notice information will be made accessible upon request in accordance with the Accessibility Standard for Information and Communication under the *Accessibility for Ontarians with Disabilities Act, 2005*. Information will be collected in accordance with the *Freedom of Information and Protection of Privacy Act*. With the exception of personal information, all comments will become part of the public record.
