### Report:

#### **Background:**

The March Water and Wastewater Maintenance Report summarizes operational data, maintenance activities, and compliance issues identified during the operating month of March 2020.

The 2019 Annual Water System Reports, for the Chepstow, Lake Rosalind, and Walkerton Water Treatment Systems, summarize the annual operations of each treatment facility submitted by Veolia, on the Municipality's behalf, to the Ministry of Environment, Conservation, and Parks (MOECP). These reports are submitted annually.

The 2019-2020 Ministry of the Environment, Conservation, and Parks (MOECP) Water System Inspection Reports summarize the compliance audit findings by the MOECP for each water system (Chepstow, Lake Rosalind, and Walkerton). These inspections take place every two years or so.

#### **Analysis**:

There were no compliance or regulatory issues with regards to the operations or maintenance of any of the three water treatment facilities. Each facility earned a 100% Final Inspection rating from the MOECP.
