Well #9 is a 79.3m drilled well fitted with a submersible pump rated at 6.8L/s at 66m head. Water flows through a UV unit for primary disinfection, followed by chlorination. Water storage and pressure is maintained by two standpipes each quipped with mixers. There are three pressure zones, two equipped with booster tations to maintain adequate pressure. The system has a standby diesel generator for mergency situations.
