4.1 Fred Kuntz, Senior Manager, Corporate Relations and Projects - Ontario Power Generation Update

Fred Kuntz, Senior Manager, Corporate Relations and Projects, Ontario Power Generation, provided an overview and an update regarding the projects being undertaken by OPG over the next year. Mr. Kuntz also confirmed OPG's respect for the decision of the Saugeen Ojibway Nation to decline having a Deep Geological Repository for low and intermediate level waste built in the area.

Mr. Kuntz described the Ivey Charging Network which involved installing fast chargers to promote the use of electric vehicles, the refurbishment of the Darlington Nuclear Station, and OPG's collaborative efforts to develop microreactors.

Mr. Kuntz also provided a summary of the community events and sponsorships that were supported by Ontario Power Generation over the past year.

Mr. Kuntz responded to questions from Council about the timing of developing the microreactors and their potential application.
