Recommendation:

That the Council of the Municipality of Brockton hereby receives Report Number PW2020-12 - Bruce County Surplus Property – 373 Bruce Road 15, Village of Pinkerton, prepared by Gregg Furtney, Director of Operations for information purposes and further directs staff to contact Bruce County Representatives to express Brockton's lack of interest to purchase or acquire this surplus property.

Report:

Background:

Bruce County staff have contacted Brockton staff about whether Brockton has any interest in purchasing some surplus land identified as 373 Bruce Road 15 in the Village of Pinkerton (Part 2 of 3R-8644, Part of Lot 25, RP NO. 63).

The property fronts on Bruce County Road 15 which is owned and managed by Bruce County. The property has an approximate total area of 1,400 square meters with a frontage of 40.23 meters and a depth of 34.24 meters. There is no building on the property currently. It is unknown whether or not the property can be connected to some sort of water supply or sanitary sewer facility. There are no municipally owned utility connections in that area. Although Brockton Staff are aware of the assessed value of the property, there have been no discussions, to date, about what the asking price would be or if the property would be transferred to Brockton in another appropriate manner.

Bruce County passed a motion on June 14, 2007 to make this property surplus. Bruce County staff have asked for a response from the Municipality of Brockton by June 30, 2020. It is the County's intention to dispose of the property. The original letter from Bruce County and a map of the property are attached to this report.

Analysis:

Upon review of the County's Surplus Property at 373 Bruce Road 15, staff do not recommend pursing the acquisition of this property.

The property fronts on Bruce County Road 15 and does not connect with any Brockton owned or operated infrastructure. Staff do not see any reason to own and then maintain this property, now or in the future.
