## **Report:**

## Background:

In light of the COVID-19 Pandemic, many municipalities across Ontario and throughout Canada have been forced to reconsider and cancel traditional Canada Day Celebrations and activities. Several Communities have begun to transform their Canada Day celebratory activities into a virtual format.

For Brockton's Canada Day 2020 Celebration, the Canada Day Committee and Staff would like to propose that Brockton's Canada Day Celebrations be celebrated through a Community Video as well as a Community Moment on Canada Day.

The following ideas are proposed by the Canada Day Committee and Recreation Staff proceeding with more detailed planning upon Council's endorsement:

#### Video Content

- Encourage families to submit video clips—musicians to submit video clips.
- Artists in town and kids draw a picture depicting Canada and submit photos of these pictures to include in virtual celebration.
- Invite people to submit pictures electronically of past celebrations.
- Family Celebration messages clips.
- Possible use of family pictures from Front door project.
- Connect Happy Valley Drone re: usage of local business photos.

• Welcome message from Mayor Peabody, MP, MPP, Rotary President

## **Canada Day Event**

- Challenge neighbours to put together best decorated street in Canada Day theme
- Fly over Brockton potential for volunteer pilots to do flyover.
- End day with snapd Canada Virtual Fireworks app event (see attachment)

#### How to Put Together

Wightman Productions will piece together a 30-45 minutes video to be shared/broadcast on such medias as:

- YouTube
- Facebook
- Brockton Webpage

Upon endorsement, the Committee and Staff would engage the community and Wightman Productions to pull the material together by June 17, 2020 for preview and editing. We would also ensure all copyright rules are followed regarding music. We would be able to preview and edit as required prior to July 1<sup>st</sup>.



## Analysis:

The Municipality of Brockton has partnered with the Walkerton Rotary Club for many years to provide a Canada Celebration for the community. This year's celebration requires a new look in order to bring our neighbours and community together safely. By creating a community celebration video we will be engaging the community to share a family photo, a Canada Day shout out or a talent.

Canada Day messages from local officials will also provide assurance that we are in it together but for this instance in celebration. The budget for this year's event will possibly see a slight increase in expenses and will not have the annual contribution of community donations from the BBQ.

The proposed snapd virtual fireworks is a unique way a large part of the community, especially youth can enjoy the thrill of fireworks through a new media. There will be no additional request of funds from the municipality and there is also a possibility of sponsorship for the video.
