Recommendation:

That the Council of the Municipality of Brockton hereby receives Report REC2020-05 - Arena Ice Plant Condenser Replacement prepared by Mark Coleman, Director of Community Services and in doing so requests an exemption to the Purchasing and Procurement Policy as per section 13.1 to accept the quote from Black and McDonald as a single source procurement for the purchase and installation of a new VC1-110 Evaporative Condenser in the amount of \$67,800.00 plus H.S.T.

Report:

Background:

As part of the 2020 work plan and approved budget, the Walkerton Community Centre Arena Ice Plant needs a new evaporative condenser. This need is identified and supported in the 2019 PINCHIN Condition Assessment of Mechanical Systems report. The current unit is at the end of its life cycle being 20 years in service with various components such as bearings, belts, fans, diffusers and piping exhibiting extensive wear and near failure.

Analysis:

Black and McDonald refrigeration is the vendor of record that Brockton uses to service the ice plant, supply parts and perform emergency repairs. Black and McDonald is currently performing the work to install the new chiller carried over from 2019 and the overhaul of the compressors. As such Staff obtained a quote (attached) for the replacement of the evaporative condenser from Black and McDonald as the qualified, knowledgeable, recommended contractor and seek Council's relief from the Purchasing and Procurement Policy requirement for tendering and proceed as a single source purchase. Delivery and installation is anticipated within 6-8 weeks.

Therefore, Staff request that the Council of the Municipality of Brockton accept the quote from Black and McDonald as a single source purchase in the amount of \$67,800 plus H.S.T.
