New Illuminated Sign

Proposal

Background

Holm Graphics, Inc. is a local sign design, fabrication and installation company founded in 2011. We have significant experience in both conventional and LED signage. We currently have 7 LED sign installations within Walkerton and approximately 25 in the region. We desire to submit a proposal to replace the current signage at the entrance to the industrial park.

Project description

As per the Request For Proposal (RFP) we are submitting two options for a double sided monument style sign located at the site of the current sign.

Option 1 will be a structure 20' tall and 8' comprised of a header section displaying the park name and Walkerton logo. There will be two separate backlite boxes with four faces for tenants in each box. These will be illuminated with LED backlighting. The dimensions of the components are called out on the drawing. This will be a double-sided sign.

Option 2 would include all of the components specified in option one plus the addition of a P-8 SMD LED double sided display. The LED display can be controlled by network cable, WiFi network or a Cellular SIM card. The display is capable of displaying both still images and videos. Content is sent to the sign via upload to a web portal. The control system is T-3 Novastar. The size of this sign would be slightly wider at 100.5" due to the LED screen being comprised of 320m wide modules. The height would remain at 20'.

All electrical components will be ESA inspected and approved.

Potential Issues

1. MTO Corridor Management; I have attempted to reach Jessica Pegalo who is our local contact for the past week via email and phone without success to discuss the project. This project is a little atypical with the sign located in the median of a road intersecting a Provincial highway. I do not anticipate any significant restrictions, but I do think a discussion with Jessica is essential prior to proceeding. The second issue is in our most recent experience it took in excess of two months to obtain a sign permit from the MTO. With a desired timeline of less than three months for completion of the sign, this could be an impediment.
2. Our LED displays are manufactured by our partner company in Shenzhen China. Typically, signs can be manufactured and delivered to us in 70 to 100 days. With the current major supply chain and shipping disruptions we are concerned that this time

frame may be extended. We are also experiencing shortages in other material particularly acrylic secondary to the Covid situation.

Compliance Statement
