This notice is to advise that the Koelen Municipal Drain Engineer's Report will be considered by the Council of the Municipality of Brockton on **Tuesday, June 23, 2020 at 7:00 p.m.\*** through an electronic Council Meeting hosted via **Zoom Video Conferencing**.

\*Please note that on May 26<sup>th</sup>, the Council of the Municipality of Brockton approved rescheduling the June 2020 Council Meeting dates to June 9<sup>th</sup> and June 23<sup>rd</sup>. **Failure to Attend Meeting:** If you do not attend the meeting, it will continue in your absence. If you are affected or assessed by this proposed project, you will continue to receive notification as required by the Drainage Act.

**What Will Happen at This Meeting?**

- Usually the engineer will present a summary of the Report to Council.
- For drains initiated by petition:
  - Petitioners will be given an opportunity to withdraw their name from the petition.
  - Other owners will be given an opportunity to add or withdraw their name to the petition.

**What Will Happen at This Meeting? (Continued)**

- Council must decide whether or not to proceed with the project and will consider a motion to adopt the engineer's report and also consider adopting a provisional by-law. Council also has the option to refer the report back to the engineer for modifications.
- All property owners affected by the drain will have an opportunity to provide their comments at the meeting, before Council makes its decision.
- Property owners do not have the right to appeal their assessment of the engineer's report at this meeting. Appeals of the assessment occur later in the process at a Court of Revision (see Drainage Act, R.S.O. 1990, c. D. 17, Sections 47 - 54).

**Petitioners:** Following this meeting to consider the engineer's report, if the petition does not comply with Section 4, the project is terminated and the original petitioners are responsible for the costs in shares proportional to their assessment in the engineer's report (see Drainage Act, R.S.O. 1990, c. D. 17 Section 43).
