### **Report:**

### Background:

The Municipality of Brockton has an agreement with the Association of Municipalities of Ontario (AMO) for the transfer of funds through the federal gas tax program. The funds are allocated to major repairs and/or replacements of the Municipality's bridges and culverts

#### Analysis:

We are pleased to see the estimated amount of the transfers for 2019 to 2023 overall steadily increase. This is a valuable resource for the effective management of the Municipality's bridge and culvert assets.

The population of Canada increased by 5% between 2011 and 2016. Municipalities that exceeded this rate of growth will receive an increased allocation in 2019; municipalities that did not will receive a decreased allocation.

Brockton's population grew by 0.3% between 2011 and 2016, so the Municipality will unfortunately receive a decreased allocation in 2019. Brockton received \$300,418.22 in 2018 and a decrease of 4.67% by 2019 and gradually increasing by 2023.
