5. Reports

5.1 Planning Report - Minor Variance Application - Reeves A-2020-009

Mark Paoli, Bruce County Land Use Planning Manager reviewed the planning report, noting that the applicant, Turner Reeves, proposed to reduce the minimum distance separation (MDS) between a dwelling and livestock facility across the road to allow a new house to be built on the vacant lot. The barn across the road is a feeder operation with a current maximum housing capacity of 300. The required MDS setback is 286 m and Mr. Reeves is requesting a setback of 197 m. The subject lands are approximately 1.5 acres, and zoned 'A1-General Agriculture'. Without zoning relief from the MDS I requirement, building a house would not be permitted. Mr. Paoli summarized the four tests for Minor Variances, explaining that the application maintains the intent and purpose of the Official Plan and Zoning By-Law and is desirable for the appropriate development of the property.

Mr. Paoli noted that he is presenting the planning reports on behalf of Dana Kieffer, Bruce County Planner, who has left for maternity leave.

Mayor Chris Peabody invited questions from the Committee of Adjustment, and the applicant.

The Applicant, Turner Reeves, inquired about the conditions of the Minor Variance. Fiona Hamilton, Clerk summarized the proposed conditions that any future development on the property conforms to the Zoning By-Law, that the decision applies only to the proposed development, and finally that the MDS I setback shall be no less than +/-197 m to the barn located 1060 Sideroad 25 N.

Mr. Paoli explained the process to Mr. Reeves noting once Bruce County receives the signed Decision Sheet from the Committee of Adjustment, a Notice of Decision would be distributed to any individuals who requested it, followed by a twenty (20) day appeal period. If no appeals are received, a Notice of No Appeals will be distributed and Mr. Reeves can obtain a building permit from the Municipality.
