#### Report:

#### **Background:**

In light of the COVID-19 Pandemic, many municipalities across Ontario and throughout Canada were forced to reconsider and cancel their traditional Canada Day Celebrations and activities. The municipality of Brockton along with several other Communities transformed their Canada Day celebratory activities into a virtual format.

Brockton via its Parks and Recreation Department promoted and produced a Community Video including past Canada Day Celebration memories and current drone footage as well as a Community Moment (Canadian Owners and Pilots Association from the Hanover Airport did a flyover of Walkerton) on Canada Day July 1, 2020. Brockton also used the services of Snapd media software to provide a Virtual Fireworks.

#### Analysis:

As of July 2, 2020, there were 588 views of the Brockton Canada Day Virtual Fireworks. If this platform were to be used again in the future, consideration could be given to partnering with another local municipality and Snapd about cost sharing the program.

As of July 28, 2020, there have been 1,808 views of the Brockton Canada Day Community Video. Wightman sponsored the production of the video.
