### Covid – 19 Update

- M. Coleman updated the ECCB with the latest information from the Ont. Gov. and the Municipality. On July 10, 2020 Premier Ford announced that our area had now moved into Stage 3. Indoor spaces may now hold up to 50 people so long as proper social distancing can take place. Groups of up to 100 may gather in outdoor locations, once again assuming social distancing can take place. In addition, social bubbles can include up to 10 people. Playgrounds are now open and signs indicating that members of the public can use the playgrounds at their own risk.

### PPE

- B. Hamilton provided a link to a website hosted by Bruce Power, which would enable Municipal Councils, Boards or Committees to submit orders for PPE materials. Groups can use the purchasing power of Bruce Power to help them acquire PPE. E. Falkiner said that the greatest need at this point was for nitrile gloves, which unfortunately, were not on the list of materials on the website.
