By-Law 2020-092

Being a By-Law to Accept a Tender from Ontario Pool Coatings Incorporated for the Restoration of Walkerton Centennial Park Pool for the Municipality of Brockton.

Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its council;

And Whereas the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9; shall be exercised by By-Law;

Whereas the Council for the Corporation of the Municipality of Brockton Council deems it expedient to accept a tender from Ontario Pool Coatings Incorporated for the drainage of Fields 3 and 4 at Brockton's Bruce Power Regional Soccer Park for the Municipality of Brockton;

Now Therefore the Council of the Corporation of the Municipality of Brockton enacts as follows;

- 1.0 That the Council of the Corporation of the Municipality of Brockton hereby accepts the tender of Ontario Pool Coatings Incorporated in the amount of \$133,480.00 plus H.S.T. for the restoration of Walkerton Centennial Park Pool as described in the attached Schedule "A" to this By-Law.
- 2.0 That the Mayor and Clerk are hereby authorized to sign on behalf of the Council for The Corporation of the Municipality of Brockton, any contracts and other documents required to authorize such purchase to proceed, and to affix the corporate seal of the Municipality of Brockton.
- 3.0 This By-Law shall come into full force and effect upon final passage.
- 4.0 This By-Law may be cited as the "Walkerton Centennial Pool Tender Acceptance By-Law".





Company Background

Ontario Pool Coatings Incorporated (OPC Inc) was founded by myself, owner Darren Borland in 2016 with the sole focus of filling a hole in a niche market (Concrete Swimming Pool Restoration). Our company OPC Inc specializes in the restoration and resurfacing of concrete and fiberglass swimming pools across Southern Ontario. OPC Inc also has a sister company Ontario Specialty Coatings that specializes in concrete restoration as a whole rather than merely the pool industry. Over the last 4-5 years in business our company has also been recruited to work out of province (Alberta & New Brunswick) due to our experience and knowledge in our niche market.

Ethan Grant would be the Project Manager in this case and would be controlling the project with supervision from Owner (Darren Borland). Jonathan Seemann also has full capability of managing this project if the situation were to arise.

This project would not require any sub contractors as OPC Inc has all required assets between labour and equipment to complete the specified work. From several large grinders, scaffolding equipment,



experienced labourers, thermo plastic applicator equipment, our staff is fully equipped to manage this project from start to finish.

Methodology

The key elements to this project are as follows:

Step 1 (Demolition):

- Removal of diving area
 - Safe, simple removal and disposal of the diving platform will be performed early on to remove the object from the working area
- Paint removal and concrete preparation
 - Nearly dustless diamond grinders will be used manually to remove all existing paint from the surface. This will take approximately 1-1.5 weeks to complete and will perfectly etch the substrate.
- Failed concrete removal
 - Chipping away of cement
- Pouring of new concrete
 - Use of Sika 1000 and Sika 123 as per manufacturers specifications
- Preparation of new concrete
 - Grinding of new concrete to smooth out and prepare for coating

Step 2 (Testing):

- All necessary testing to be completed including but not limited to:
 - Ph Test
 - Heat Test
 - Moisture Test

Step 3:

- Coating of entire pool
- Application of lines in pool

The methodology behind this plan is to be extremely meticulous and to take care of all preparation for the first 2 weeks. This will allow us to ensure we have a perfect substrate for our coating to adhere to. The reasoning for this is that the most important aspect of this particular project will be the preparation



work, as it is with most coatings. Taking care of all of the preparation work first will allow us to eliminate the mess as well.

The key municipal resources that will be required to complete these tasks will be washroom facilities, basic hydro and access to water for pressures washers and filling of buckets. These municipal resources will need to be available throughout the whole course of the project. It is preferred that we also have access to the facilities on Saturdays incase we feel the extra work day will help with obtaining substantial completion on time.

Workplan/Schedule

Please find our schedule listed below:

- 1) **Start Date: Monday August 31st 2020**
 - Throughout the first week of work the goal will be to accomplish all demolition and to get a good start on the diamond grinding.
 - Diving platform should be removed
 - Troubled concrete should be removed and Re-poured
 - Diamond grinding should be well underway
- 2) **Site Visit/Meeting: Tuesday September 8th 2020**
 - Would be a good date for a site visit for all parties involved to see how majority of the preparation work had progressed
- 3) **Site Visit/Meeting: Monday September 14th 2020**
 - All preparation work should be completed or nearly completed
 - Testing will than occur
 - Potential beginning of application on walls and coping (walls and coping to be completed first)
- 4) **Site Visit/Meeting: Monday September 21st 2020**
 - If installation on the walls is not completed, they will be completed this week
 - Beginning of floor will begin
- 5) **Site Visit/Meeting: Monday September 28th 2020**
 - Floor and line installation will take place
- 6) **Finish Date: Prior to October 10th 2020**

*Please note that we have left a fair amount of "buffer time" in the event weather or other unforeseen circumstances slow us down.
