## By-Law 2020-122

### Being a By-Law to Amend the Van Nes Municipal Drain By-Law for the Municipality of Brockton.

---

**Whereas** the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its council;

**And Whereas** the *Municipal Act, 2001, S.O. 2001, c. 25*, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9; shall be exercised by By-Law;

**And Whereas** the Council for The Corporation of the Municipality of Brockton enacted By-Law 2019-081 on September 24, 2019, adopting the Engineer's Report and Schedule of Actual Assessment for the Van Nes Municipal Drain;

**And Whereas** the Council for The Corporation of the Municipality of Brockton deems it expedient to amend the Schedule of Actual Assessment for the Van Nes Municipal Drain contained in Schedule "A" to By-Law 2019-081;

**Now Therefore** the Council of the Corporation of the Municipality of Brockton **Enacts as Follows:**

- 1.0 That the Council of the Corporation of the Municipality of Brockton hereby amend Schedule "A" to By-Law 2019-081 by replacing the Schedule of Actual Assessment for the Van Nes Municipal Drain with the 2020 Schedule of Actual Assessment attached hereto as Schedule "A" and forming a part of this By-Law.
- 2.0 That By-Law 2019-081 be hereby amended;
- 3.0 That this By-Law shall come into effect upon final passage.
- 4.0 This By-Law may be cited as the "Amend Van Nes Municipal Drain By-Law".
