In a letter to your Council dated September 15th, 2020, Mayor Buckle outlined that our Municipality will be reaching out to provide updates and information in relation to the NWMO's Adaptive Phased Management project and South Bruce's involvement in the site selection process on a regular basis.

As such, we have asked the NWMO to facilitate a regional environmental workshop specifically for municipal and county officials whose jurisdiction may be impacted by various environmental assessments and studies which will take place in the near future.

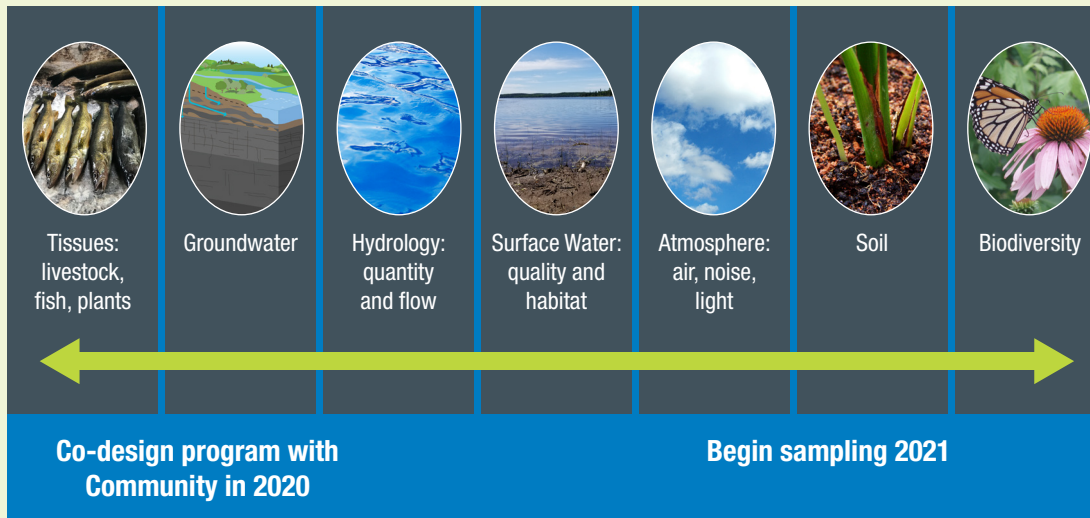
